David Zofko, Executive Director of the Ohio Manufactured Homes Commission (OMHC) will conduct this 2-hour seminar focused on the following topics:

- HUD's Final Rule (which only pertains to the set of NEW homes).
- The Commission's view on the changes required to the OMHC Rules for the secondary set of a home and/or used homes.
- The Commission's considerations regarding the regulation of pre-HUD home sets and the degree of regulation.
- The Commission's view on prosecuting unlicensed installers and illegal sets and new Rules to assist in enforcement.
- How to file a complaint to the Commission regarding an illegal set or an unlicensed installer; what information is required.
- The Commission's consideration to set the inspection fees to help establish uniformity in the industry.
- A general discussion regarding the ODH, Commerce Department's local plumbing inspector's inspection jurisdiction.
- The Board of Building Standard's cooperation with the OMHC to inform and educate city and county building departments about the OMHC.
- The Commission's future considerations and issues on the horizon.

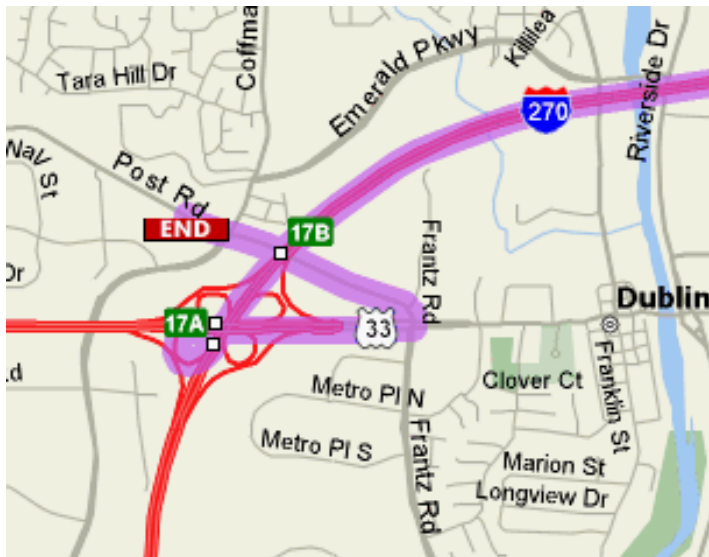
