**NOTES:** OMHA membership dues are based on the calendar year, January through December.

It is the OMHA Board of Directors' policy that to be a qualified OMHA member, all relative businesses must be members of OMHA. (For example, if the same person owns three communities, all three communities must be OMHA members. Or, if you have a retailer center and a community, both businesses must be OMHA members.) This policy was created out of fairness to all members. If only one community or retail location was required to join, but several relative manufactured and modular home businesses were owned by the same company benefits would still be received by the non-member companies.
